Diversification is an investment strategy that involves spreading your investments across various financial assets, industries, and geographical regions.

The primary goal is to reduce risk and enhance the potential for returns. By not putting all your eggs in one basket, you can potentially safeguard your portfolio from significant losses if a particular asset or sector performs poorly.

Asset Class Diversification

This involves investing in different types of assets such as stocks, bonds and commodities.

Risk Reduction

Different asset classes react differently to market conditions. When stocks go down, bonds might go up, balancing your portfolio.

Diversifying across asset classes can potentially provide more stable returns over time.

Geographical Diversification

This means spreading your investments across various countries and regions.

Reduced Regional Risk

Different regions may experience economic cycles differently. If one country's economy is down, another might be thriving.

Exposure to Growth Opportunities

Investing globally allows you to take advantage of growth opportunities in emerging markets and other high-growth regions.

4 Monitor and Rebalance

Keep an eye on your portfolio's performance. Periodic rebalancing may help to maintain desired level of diversification.
